**ORDINANCE NO. 2017 - 13**

**AN ORDINANCE OF THE MAYOR AND CITY COMMISSION  
OF THE CITY OF HALLANDALE BEACH, FLORIDA,  
AMENDING THE ADOPTED BUDGET FOR FISCAL YEAR  
2016-2017 TO REFLECT THE REVENUE, EXPENDITURES,  
APPROPRIATIONS AND RELATED TRANSACTIONS  
ASSOCIATED WITH THE STATE REVOLVING LOAN  
AGREEMENT #WW061720; PROVIDING FOR CONFLICT;  
PROVIDING FOR SEVERABILITY; AND PROVIDING AN  
EFFECTIVE DATE.**

**WHEREAS**, Section 166.241 authorizes a municipality to amend its adopted budget anytime during the fiscal year or within sixty (60) days after the end of the fiscal year for which the budget applied; and

**WHEREAS**, on May 21, 2014, the City Commission approved Resolution 2014-48, authorizing the City to submit the Facilities Plan to the Florida Department of Environmental Protection for approval and initiative of the State Revolving Fund process; and

**WHEREAS**, on December 2, 2015, Ordinance No. 2015-16 was approved for the State Revolving Fund loan program, authorizing the City Administration to make findings, authorize the loan application and agreement, establish pledged revenues, designate authorized representatives for the loan; and

**WHEREAS**, the City and FDEP executed the loan agreement for the total amount of state financial assistance of five hundred fifty thousand (\$550,000.00) dollars; and

**WHEREAS**, the City Administration proposes that the FY 2016-2017 adopted budget be amended to include the revenue, expenditures and related transactions associated with the State Revolving Loan Agreement #WW061720 in the amount of five hundred fifty thousand (\$550,000.00) dollars; and

**WHEREAS**, this budget amendment will increase the FY 2016-2017 adopted budget as indicated in Exhibit 5 of this ordinance; and

39           **WHEREAS**, the Mayor and City Commission have determined that it is in the best  
40 interest of the City and its residents to amend the FY2016-2017 adopted budget as  
41 reflected in the attachments; and

43           **WHEREAS**, the Mayor and City Commission have determined that this proposed  
44 budget amendment is timely under Florida Statutes 166.241 and is being adopted in the  
45 same manner as the original adoption of the FY2016-2017 budget.

47           **NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY**  
48 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

49           **SECTION 1.** The foregoing "Whereas" clauses are adopted herein.

52           **SECTION 2. Adoption of Budget Amendment.** The Mayor and City  
53 Commission hereby adopt the budget amendment to the FY 2016-2017 adopted budget  
54 as set forth in Exhibit 5 of this ordinance.

55           **SECTION 3. Conflict.** All ordinances, parts of ordinances, resolutions, or parts  
56 of resolutions in conflict herewith are hereby repealed, to the extent of the conflict.

58           **SECTION 4. Severability.** Should any provision of this Ordinance be declared by  
59 a court of competent jurisdiction to be invalid, such decision shall not affect the validity of  
60 this Ordinance as a whole or any portion thereof, other than the part that is declared to be  
61 invalid.

64           **SECTION 5. Effective Date.** This Ordinance shall take effect immediately upon  
65 adoption.
