16	patrol the District, forty (40) hours a week, seven (7) days a week on a rotating schedule,
17	fifty-two (52) weeks a year (all holidays included); and

19	WHEREAS, on September 30, 2017, the contract with Security Alliance LLC, to
20	provide security guard services for the Golden Isles Safe Neighborhood District (GISND)
21	will expire; and
22	
23	WHEREAS, on June 8, 2017, a Request for Proposal was released for Security
24	Services for the GISND and six (6) security firms offered proposals; and
25 26	WHEDEAC the Evolution Committee assumed assertion the Co. "
	WHEREAS, the Evaluation Committee recommends awarding the Security
27	Services to Regions Security Services, Inc., a regional security firm with five (5) years of
28	experience, whose references offered positive reviews of their past and present security
29	assignments and which submitted the lowest bid amount of all the applicants; and
30	WHEREAS, the proposed agreement has an annual cost for the first three (3)
31	years of the agreement is proposed at \$160,974 per year, with three (3) additional optional
32	renewals subject to a 2% adjustment. The current costs for security services is \$168,233
33	per year. Sufficient funding is available in FY2017/18 Budget.
