14	WHIEDEAO CONTROL AND ON A CONTROL OF THE CONTROL OF
15	WHEREAS, pursuant to Chapter 23, Section 23-4, Competitive Bidding Required,
16	all purchases of and contracts for equipment, supplies and contractual services, when the
17	estimated cost shall exceed \$50,000 shall be based on competitive bids. Furthermore,
18	pursuant to Chapter 23, Section 23-6, Award of Contract, the City Manager, shall have the
19	authority to recommend to the City Commission award of contracts; and
20	
21	WHEREAS, License Plate Recognition (LPR) cameras are specialized cameras
22	with built-in software to help identify and record license plates. The license plate
23	information captured on the LPR is compared with the Florida Department of Law
24	Enforcement's database; and
25	
26	WHEREAS, the City of Hallandale Beach has six (6) LPR cameras in the two Safe
27	Neighborhood Districts. The LPR cameras are at the entrances of the Three Islands Safe
28	Neighorhood District and the entrance and exit of the Golden Isles Safe Neighborhood
29	District; and
30	
31	WHEREAS, this technology has assisted in serving as a deterrent to crime and as
32	a forensic tool to solve crimes after they occur. There have been arrests made as a result
33	of the alerts from the cameras; and

36	WHEREAS, City Administration proposes to add new LPRs to all main entrances
37	to the city. The proposed locations for the new LPR cameras include: I-95 and W.

Hallandale Beach Blvd, I-95 and W. Pembroke Road, NW 8 Avenue and Pembroke Road,

WHEREAS, staff released a request for proposals. All proposals were required to provide a five (5) year lease agreement for the installation of License Plate Recognition (LPR) Systems within eleven (11) sites and two (2) mobile LPR trailers. The lease agreement is to include all hardware, installation, software, software updates, and warranties. Further, the proposals are to include a maintenance agreement to maintain the entire LPR system. The maintenance agreement would cover all service costs, labor, and quarterly inspections for system performance. Finally, the lease agreement will replace the existing six (6) LPR cameras in the Safe Neighborhood Districts to increase system reliability and performance; and

WHEREAS, the City conducted a competitive solicitation and received responses from five (5) proposers, which were evaluated by a selection committee; and

WHEREAS, the City Administration recommends that the City Commission award RFP # FY 2017-2018-008 to Vetted Security Solutions, LLC. For a cost not to exceed one hundred ninety seven thousand six hundred and twenty eight dollars (\$197,628) annually for a term of five (5) years. This cost includes replacing and installing forty eight (48) new LPR cameras and the maintenance of the LPR system; and

WHEREAS, the Mayor and City Commission have determined that the City Administration's recommendations are in the best interest of the City and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. The foregoing "Whereas" clauses are incorporated herein.
