3 A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF  
4 THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDED  
5 BID # FY2018-2019-011, PURCHASE OF GLOCK  
6 FIREARMS/TRADE-IN-ALLOWANCE AND ACCESSORIES, TO  
7 THE LOWEST RESPONSIVE BIDDER, LOU'S POLICE  
8 DISTRIBUTORS, INC. FOR AN AMOUNT NOT TO EXCEED  
9 FIFTY EIGHT THOUSAND ONE HUNDRED NINETY THREE  
10 (\$58,193.00) DOLLARS FOR THE PURCHASE OF GLOCK 9MM  
11 FIREARMS; AUTHORIZING THE CITY MANAGER TO EXECUTE  
12 ALL RELATED DOCUMENTS TO EFFECTUATE THE  
13 PURCHASE; AND PROVIDING AN EFFECTIVE DATE.

16 WHEREAS pursuant to Chapter 23, Section 23-4, Competitive Bidding Required, all  
17 purchases of and contracts for equipment, supplies and contractual services, when the estimated  
18 cost shall exceed \$50,000 shall be based on competitive bids. Furthermore, pursuant to Chapter  
19 23, Section 23-6, Award of Contract, the City Manager, shall have the authority to recommend to  
20 the City Commission award of contracts; and

22 WHEREAS, since 1998 the Hallandale Beach Police Department has issued the Glock  
23 .40 caliber firearm to all sworn police officers. However, the current inventory was purchased  
24 over 30 years ago and presents significant wear and needs replacement; and

26 WHEREAS, on August 1, 2019, the City issued an invitation to Bid #FY 2018-2019-011,  
27 Purchase of Glock Firearms/Trade-in-Allowance and Accessories, via email to three hundred and  
28 thirty-three (333) City vendors, also on the City's and CRA's social media pages and advertised  
29 on the City's website, the Hallandale Beach Chamber of Commerce website, and Demandstar;  
30 and

31 WHEREAS, a pre-bid meeting was held on August 5, 2019 and zero (0) firms attended  
32 the pre-bid meeting; and

34 WHEREAS, on August 21, 2019 bids were due and the City received two (2) responses;  
35 and

37 WHEREAS, staff evaluated the responses from the two (2) firms and selected Lou's Police  
38 Distributors, Inc. as the lowest, responsive, responsible bidder. Lou's Police Distributors, Inc.,  
39 submitted a bid in the amount of fifty-eight thousand one hundred ninety-three (\$58,193) dollars.  
40 The total cost of the Glock 9mm firearms is \$93,633 dollars, however, this amount has been

41 discounted by \$35,440, which represents the City's trade in allowance for its existing Glock .40  
42 caliber firearms inventory. The result is a total net cost to the City in the amount of \$58,193; and

44 **WHEREAS**, the City Administration recommends that the City Commission award BID#  
45 FY 2018-2019-011, Purchase of Glock Firearms/Trade-in-Allowance and Accessories, to Lou's  
46 Police Distributors, Inc. as the lowest, responsive, responsible bidder in the amount of fifty-eight  
47 thousand one hundred ninety-three (\$58,193) dollars; further authorizing the City Manager to  
48 execute all related documents to effectuate the purchase.

50 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF**  
51 **THE CITY OF HALLANDALE BEACH, FLORIDA:**

53 **SECTION 1. City Commission Award.** The Mayor and City Commission hereby award  
54 BID # FY 2018-2019-011, Lou's Police Distributors, Inc., the lowest, responsive, responsible  
55 bidder in the not to exceed amount of fifty-eight thousand one hundred ninety-three (\$58,193)  
56 dollars.

57 **SECTION 2. City Manager Authorization.** The Mayor and City Commission hereby  
58 authorize the City Manager to execute any and all related documents to effectuate the purchase  
59 of Glock 9mm firearms for the City's sworn police officers.

61 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its  
62 passage and adoption.
