19	Section 23-12, Procedures for purchases in excess of \$50,000, (4) Rejection of Bids, the City
20	Commission may authorize City Manager to reject all bids; and

22	WHEREAS, Staff recommends that the Mayor and City Commission authorize the City
23	Manager to reject all bids and proceed in the best interests of the City, pursuant to the procedures
24	prescribed in the Code for ITB # FY 2021-2022-012 Infiltration and Inflow Phase 2A Lateral and
25	Televising Line Project.

27	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF
28	THE CITY OF HALLANDALE BEACH, FLORIDA:

30	SECTION 1. Whereas Clauses. The foregoing "Whereas" clauses are incorporated
31	herein.

33	SECTION 2. City Manager Authorization. The Mayor and City Commission hereby
34	authorize the City Manager to reject all bids and proceed in the best interests of the City pursuant
35	to the procedure prescribed in the Code for ITB # FY 2021-2022-012 Infiltration and Inflow Phase
36	2A Lateral and Televising Line Project.

37	SECTION 3. Effective Date. This Resolution shall take effect immediately upon its
38	passage and adoption.
