**RESOLUTION NO. 2022- 136**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF  
THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING  
THE CITY MANAGER TO REJECT RFP # ITB # FY 2021-2022-  
012 INFILTRATION AND INFLOW PHASE 2A LATERAL AND  
TELEVISIONING LINE PROJECT; AND PROVIDING FOR AN  
EFFECTIVE DATE.**

**WHEREAS**, on May 26, 2022, the City released Invitation to Bid (ITB) FY 2021-  
2022-012 Infiltration and Inflow Phase 2A Lateral and Televising Line Project; and

**WHEREAS**, two (2) proposals were received and reviewed by the Procurement  
Department, which found that both proposals were non-responsive having failed to meet Sec. 2a  
or 5b; and

**WHEREAS**, pursuant to City of Hallandale Beach Code of Ordinances, Chapter 23,  
Section 23-12, Procedures for purchases in excess of \$50,000, (4) Rejection of Bids, the City  
Commission may authorize City Manager to reject all bids; and

**WHEREAS**, Staff recommends that the Mayor and City Commission authorize the City  
Manager to reject all bids and proceed in the best interests of the City, pursuant to the procedures  
prescribed in the Code for ITB # FY 2021-2022-012 Infiltration and Inflow Phase 2A Lateral and  
Televising Line Project.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF  
THE CITY OF HALLANDALE BEACH, FLORIDA:**

**SECTION 1. Whereas Clauses.** The foregoing "Whereas" clauses are incorporated  
herein.

**SECTION 2. City Manager Authorization.** The Mayor and City Commission hereby  
authorize the City Manager to reject all bids and proceed in the best interests of the City pursuant  
to the procedure prescribed in the Code for ITB # FY 2021-2022-012 Infiltration and Inflow Phase  
2A Lateral and Televising Line Project.

37            **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its  
38 passage and adoption.


